This event will take place on March 23rd & 24th, 2019 and will be held at **Patriot High School Theatre located at 4355 Camino Real Jurupa Valley, CA 92509.** The event theme is "OUR DREAM, OUR PURPOSE, OUR VISION."

Riverside County is comprised of 23 school districts and services 349,151 school-aged youth, with a school dropout rate of 3.2%, just below the state rate of 3.8%.

Anointed Vessel Productions make an impact by providing "PROJECT HEARTBEAT," an after school performing arts educational program targeting youth age 11-17 from low income families. The program provides a platform for creative expression and positive self-identity for increased confidence and improved academic achievement. VENDOR AGREEMENT

This is an agreement between Anointed Vessel Productions, (hereafter referred to as "Host") and _____ (hereafter referred to as "Vendor").

WHEREAS, the Host will be hosting its Music and Arts Cultural Awareness Extravaganza at Patriot High School on March 23, 2019, starting at 7:30pm, and has the ability to grant an opportunity for vending during the above mentioned Event, and

WHEREAS, the Vendor desires to vend at and during the above mentioned event, and has issued the Host a sum of \$_____ for an opportunity to vend at the event.

NOW THEREFORE, the Host and Vendor both agree to the following terms:

1. Vendor will be given access to the place that is agreed upon by both parties no less than 1 hours before the Event starts to set up the Vendor's station, goods to be sold, and anything else that is needed and customary to vend at that specific location.
2. The Vendor will not vend any items or services that are not disclosed here at the event without prior written consent from the Host. Vendor space, if granted, will be on the basis of this list. Items that will be sold:

3. Vendor will receive recognition from the stage during event and advertisement in the event program.
4. Vendor agrees to donate an in-kind item with a minimum value of \$25 for the silent auction.
5. Vendor's staff may exhibit goods that are for sale only while the staff is within the area of the vendor's specified location.
6. Vendor's staff will be properly dressed and their appearance will be clean and neat and they shall conduct themselves in an orderly fashion.

7. There is to be no loud distracting music, noise, and or sound amplification devices used by Vendor's staff at the above mentioned Event.

8. Vendor will have access to the location for up to 1 hour following the event has concluded to dismantle and remove all items brought to the event by vendor. Vendor shall leave the location free from trash and in similar condition that it was in before the Vendor was there.

9. Vendor agrees to indemnify and hold harmless the Host from any liability whatsoever free from any damages based or asserted upon any services of Vendor arising out of or in any way that may develop in connection with participating in the above mentioned event including but not limited to property damage, bodily injury, or death or any other kind or nature whatsoever arising from the participation of vendor.

Applicable Law

This contract shall be interpreted according to the laws of the State of California. Jurisdiction and venue shall be agreed upon in the appropriate courts in the County of Riverside, State of California. Should action be brought to enforce or interpret the provision of this agreement, the prevailing party shall be entitled to attorney fees in addition to whatever other relief is granted.
